

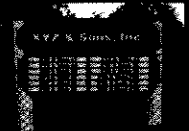

KAILUA VILLAGE SPECIAL DISTRICT <i>(The sign code for the Kailua Village Special District (KVSD) differs from the sign code for the rest of Hawaii County, and there are special provisions that affect signs within the Kailua Industrial Subdivision District and the Kailua Village Core area. Signs located within the KVSD need to be reviewed by the Kailua Village Design Commission (KVDC). Eleven copies of your application packages will be needed to distribute to the KVDC before the next scheduled meeting. HOW TO CONTACT US

• This chart is a reference. Please contact the Building Dept. (327-3520) in West Hawai'i. They enforce sign ordinances from Kohala, Waimea, Waikoloa, Kona, and to South Point Road in Ka'u.

The Building Dept. for East Hawai'i (961-8331) enforces sign ordinances from the southern edge of Na'alehu to Waimea Country Club.

• You may contact the Planning Dept., to verify the applicable zone at the West Hawai'i office (327-3510) or East Hawai'i office (961-8288).

PERMIT APPLICATION

PLEASE COME TO EITHER THE HILO OR KONA BUILDING DIVISION TO FILE AN APPLICATION FOR: Window Signs, Subdivision Identification Signs, Marquee Signs, Wall Signs, Ground Signs, Directory Signs, and Temporary Banners Over a Street.

WHAT IS REQUIRED OF THE APPLICANT?

Two sets of Plans showing:

- Entire parcel with all buildings on the property including relevant existing signs (if there are any), location of proposed sign, and street frontage(s).
- Detailed illustration of content and the dimensions. Elevation drawings, except for ground signs.
- Description of installation.
- Requirements for an electrical permit, if applicable (see Electrical Requirements for Sign Permit).

The County inspects signs when the installation is complete.

ELECTRICAL REQUIREMENTS FOR SIGN PERMIT

An electrical permit is required for:

- Signs that contain electrical lighting components and that are hard wired to an existing sign circuit.
- Installing a new sign circuit or outlet.
- Lighting installation outside of sign.

Exception: If the sign is a factory-manufactured unit that will be cord-and-plug connected into an existing sign circuit or outlet.



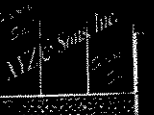
Provide the following information with the electrical permit application:

- Site drawing
- One line circuit diagram
- Location of exterior lighting
- Interior lighting sign detail (type lighting fixture, wattage, etc.)
- Sign lighting electrical components unless factory manufactured
- Sign application

VIOLATIONS

Illegal sign owners will receive a written warning, requesting removal of the sign within 10 working days. If the illegal sign is not removed, Public Works will confiscate it and the owner will be assessed a fine.

Fines: First offense is up to \$500; subsequent violations range up to \$1,000 or \$100 per day, followed by criminal prosecution.

TEMPORARY		
TEMPORARY	BANNER	TEMPORARY PAINTED WINDOW SIGN
		
Any sign which is not permanently installed or constructed.	A sign made from material that is not rigid and is not framed.	A sign that is painted on a window that is seasonal or temporary in nature.

Temporary signs are good for 30 or 60 days. They do not require a permit, but must promote a meeting or a special event occurring at a specific time. Both signs must be removed within 72 hours of the conclusion of the special event.

32 sq feet is the maximum sign size to promote a special event for 30 days in any district, (see districts on the opposite page). The sign does not need to be at the place of the event or the meeting.




For temporary signs up to six (6) months, only one sign is allowed and the signs must be displayed at the location of the event. There are two sizes. For ag/open/residential the maximum size is 8 sq feet. For commercial/industrial the maximum sign size is 32 sq feet.

APPEALS

To file an appeal, contact Board of Appeals, c/o Planning Department, Aupuni Center, 101 Pauahi St. Ste. 3, Hilo, Hawai'i 96720. For a copy of the rules and procedures for the Board of Appeals, search "Board of Appeals" at www.co.hawaii.hi.us.

VARIANCES

To file a variance, contact the Hilo or Kona Building Division.

A sign that moves and isn't secured to anything. It may be inflatable such as a balloon or an airplane banner.	A sign with moving words or parts, that flashes messages frequently.	Any sign that is not permanently attached to the ground or a permanent structure.

- Sandwich boards
- Signs on utility poles
- Temporary signs for ongoing commercial use such as sandwich boards or banners
- Signs on County property, alongside a road and in a sidewalk
- County-owned property
- Billboards
